Application Process:

- SM&NC will review all vendor applications
- All vendors will be notified of their approval via email
- Vendors will be sent a payment link through the SM&NC online system for payment. Payment is required to hold space. Further information will be provided upon payment.

SM&NC Market Rules & Guidelines

- Vendors at the SM&NC EcoVintage Flea Market are to park only in the specified area. Each producer will be assigned 16-24 feet or the equivalent of two or three parking spaces, depending on vendor attendance. Vendors are allowed to keep 1 car or small vehicle within their space. Spaces will be assigned first-come, first-served.
- Vendors should complete set up before 10 AM.
- Market will occur Rain or Shine. Vendors may bring tents as long as they fit into their spaces. Vendors must provide their own tables and chairs.
- We are looking for vendors in the following product categories: CT/NY grown produce/dairy/eggs/meat/plants/flowers; local bread/baked goods; vintage/thrifted household items, clothes, toys; antiques; locally made, natural skin care/soaps; recycled and reusable home products; etc.
- Sellers of any food products must have their prices displayed
- **Items may not be packaged in single-use plastics; plastic bags and Styrofoam are not allowed**
- Weapons of any kind, even antique, alcohol/drug items, and live animals are not allowed at the market
- Vendors must remove unsold products and clean up their stalls before leaving the market.
- All vendors must dress appropriately, and shoes and shirts are required.
- If vendors have their own product liability insurance; you must be prepared to present at the market.
- Seller assumes full liability for the products they sell.
- Vendors are expected to treat all staff and participants with respect. We reserve the right to remove any vendor who behaves in a hostile or unprofessional manner.
- **Accepted vendors will be asked to pay their entry fee through a link to the SM&NC's registration system. We will not ask for payment in any other manner.**
- **Fee to participate in the EcoVintage Flea Market & RecycleFest is \$25 per vendor**
- THE MARKET MANAGER RESERVES THE RIGHT TO DENY VENDOR PRIVILEGES TO ANY VENDOR THAT FAILS TO COMPLY WITH THESE VENDOR RULES OR FOR ANY VIOLATION OF CITY, STATE OR FEDERAL LAWS RELATED TO VENDOR ACTIVITIES DURING MARKET.
